Spring fire safety tips

Fire Marshal 860-779-3411 option 9 69 South Main St. PO BOX 356 As spring approaches thoughts turn to cleaning up outside and making repairs around the house and yard. Keeping a few safety thoughts in mind will help keep you fire safe.

INSIDE THE HOME

- ☐ Check and clean smoke/carbon detectors
- ☐ Check your fire extinguisher's
- ☐ Check for damaged or overloaded extension cords
- ☐ Prepare for upcoming storms: flashlights, generators, portable radios and batteries, bottled water etc.

OUTSIDE THE HOME



- ☐ Clean all debris from around your home, garage, and other outbuildings
- ☐ Check your propane grills and other items for leaks or damage
- Check any outdoor electrical outlets or cords for damage from the winter
- ☐ Make sure you have extra fuel on hand for your gas/propane appliance's or tools
- ☐ Brush piles: Burn them with a permit! Stop by the office to apply.

And the most important.....

Make and talk with your children about a fire drill plan for your home in case of storm emergencies or fire.

News From the Tax Collector's Office

It's April and you know what that means! The final installment of taxes are due!

• Please note that the legal notice for when taxes are due will now be published in the Killingly Villager, instead of the Norwich Bulletin.

The fourth installment for real estate and personal property taxes are due this month

(April 1st -May 2nd). You can pay your bills three different ways:

- You can mail in a check to PO Box 253, Brooklyn, CT 06234.
- You can pay online with a credit card (2.50% fees for a credit/debit card, \$3.95 fee for a Visa Debit Card ONLY, and \$2.00 for an electronic check).
- You can also come into the office and pay in person with check, cash, or card (fees still apply if you pay in the office).

Tax Bills are Online!

- Go to www.brooklynct.org. Staying on the home page, scroll down until you see three yellow buttons. Click on "Online Payments." It will bring you to a link, click on the link.
- You will be brought to the search page. Type in your last name space first initial (ex. John Doe would type in Doe J). You will be able to see your tax bills, date(s) of payment, and how much you paid to the Town of Brooklyn during a calendar year. You can also print out your tax bills for your records.

- ◆ REVALUATION: Our town-wide revaluation has been completed. The values are for 2015 Grand List and will be reflected in the July 2016 tax bills.
- ◆ ELDERLY and/or DISABLED HOMEOWNERS: We are accepting applications until Thursday May 12th, 2016. To be eligible for this tax credit:
- You or your spouse must be at least 65 years of age as of December 31, 2015 or over 18 and permanently disabled per Social Security.
- The property must be the applicant's primary residence (domicile).

 You must be a permanent resident of Connecticut. You must own the property or hold tenancy for life or for a term of years, which makes the applicant liable for payment of taxes (CGS Sec. 12-48) as of October 1, 2015. The property must be the applicant's primary residence (domicile).
- Your 2015 income cannot exceed \$42,900 if you are married or \$35,200 if unmarried.
- You must provide the Assessor with a copy of your SSA1099 for 2015.
 Please call the Assessor's Office at 860-779-3411 option 6 to make an appointment to apply.
- RENTER REBATE APPLICATIONS: Renter Rebate applications will begin Monday, April 4, 2016.



We will accept applications until Thursday, September 29, 2016. To be eligible for this tax credit:

- You or your spouse must be 65 years of age or older or over 18 and totally disabled through Social Security.
- Applicants must submit their SSA 1099 from Social Security for 2015 and proof of any other income, Federal Income Tax form if you were required to file, rent receipt for the entire year and information from Eversource (CL&P). All information must be for the 2015 year. Income cannot

exceed \$42,900 for married or \$35,200 for single.

- ◆ ADDITIONAL VETERAN'S APPLICATIONS: We are accepting applications until Thursday September 29, 2016.
- Armed Service Members: Connecticut Resident in Military Service or Exemption for Federal Soldiers & Sailors Civil Relief Act forms are available on our website and must be filed with the Assessor by December 31, 2016.



Due to the difficulties the Connecticut Department of Motor Vehicles is having with their new software, we ask all taxpayers to review their July 2016 tax bills for accuracy. If you believe you have received a bill in error, please contact us so we may investigate at 860-779-3411 opt 6.

Town Clerk 860-779-3411 Option 4 Fax: 860-774-5732 4 Wolf Den Rd PO BOX 356 Primary day for State, District or Municipal offices (if held) will be August 9, 2016 this year. Although the deadline to switch from one major party to another for the Presidential Primary on April 26th has passed, there is still time to make the switch for the August primary. The deadline is May 6, 2016 and you can make the switch with the Town Clerk, the Registrar, by mail or online.

Are you permanently disabled, but wish to vote? You might be eligible for Permanent Absentee Ballot Status. An absentee ballot

application must be submitted to the Town Clerk's office with a note from your doctor stating that you have a permanent disability that prevents you from voting at the polls. Once received, you will automatically be mailed an absentee ballot for every election.

DOG LICENSES



June is dog license month! Connecticut State statute requires that all dogs over six months old be licensed in your town. Proof of up-to-date rabies vaccinations—with the expiration date—is required with all licenses. Fees are as follows: \$19.00 per dog or \$8.00 per dog that is spayed/neutered. You must bring proof from your vet that your dog has been spayed/neutered. All dog licenses expire on June 30th and there is a \$1.00 per month late fee after that date.

Free Workshop on Septic System Care and Maintenance

On April 12, 2016, the Eastern Connecticut Conservation District (ECCD), in partnership with the Pomfret Conservation Commission, will be hosting a free workshop on Septic System Care and Maintenance. This workshop will take place beginning at 7 PM at the Connecticut Audubon Society Grassland Bird Conservation Center located at 218 Day Road in Pomfret Center.

A well-functioning septic system is as important to your home as the heating system or your water supply. Without proper maintenance, or if the system is used improperly for disposal of items not meant to go in there, the system can fail, requiring costly repairs or replacement. At this workshop, you will learn about common avoidable causes of system failures, what the signs of a system failure are and, if your system is in need of replacement, what funding options are available to help with this cost. The workshop agenda is still being finalized as this article is going to print, but be prepared for a few fun surprises!

A free septic system record keeping file folder will be given to workshop participants that print, complete, and turn in an ECCD Septic System Survey. You can download a copy of this survey by visiting the ECCD website at http://www.ConserveCT.org/Eastern, then click on Current Projects, and then the Mashamoquet Septic Upgrades tab. The survey requires no site specific information, but will help us to better understand local opinions regarding septic tank maintenance and upkeep.

Also, at this workshop, you will learn about septic system replacement rebates of \$2,000 available for homeowners in special priority areas along White Brook in Brooklyn, where higher than allowable levels of fecal bacteria were found. Is your home in a priority area? Visit the ECCD website www.ConserveCT.org/ Eastern and click on Current Projects followed by the Mashamoquet Septic Upgrades tab.




Street Numbers: For safety, all street numbers should be visible from the street. Block numbers at least 3 inches in height should be located in a conspicuous place such as on a building, mailbox, or similar object. Failure to identify the street number of the property can lead to delays in an emergency and fines (Town Ordinance 8-5), so please make sure your street number is visible.

Land Use News

Brooklyn Plans for Groundwater Protection

The Conservation Commission along with town staff and representatives from land use boards recently completed the Brooklyn Source Water Protection Plan. The team, led by Marc Cohen, a specialist in source water protection from the Atlantic States Rural Water & Wastewater Association, met over the past year to develop the plan that identifies aquifer areas and includes management tools to protect aquifers that have the potential to supply a public water system. Protection of these areas is critical to insuring there will be adequate clean groundwater sources in the future. Emergency Management and Homeland Security Committee



The Town of Brooklyn is planning to create a Community Emergency Response Team (CERT) to assist in the emergency preparedness and response efforts in town. Our hope is to develop a strong and dedicated CERT unit who can assist Town Officials, the Fire Departments, Brooklyn's emergency management team, and other

emergency responders in a disaster situation. According to the CERT website (http://www.fema.gov/community-emergency-response-teams/), those who join the teams will be educated in basic disaster response skills. Those skills include, but are not limited to, fire safety, light search and rescue, team organizations, and

disaster medical operations. The training takes around 20 hours and is open to anyone who is 18 or older. The training will be offered at the Northeast District Department of Health at 69 South Main St, Brooklyn, CT 06234. There is no cost to anyone who participates. You must attend all the classes and pass all the course requirements to join the Brooklyn CERT Unit.

Do you want to be a part of the election process? There are opportunities for you to become involved at the polls. The Registrars are looking for a few good civic-minded citizens who would like to become state certified election moderators. Also, there are positions available as poll workers during the elections as well. Please call or email the Registrars at your convenience for further information.

Please note, that in order to vote in the Presidential Preference Primary, you must be enrolled in that political party: To be eligible to vote in the Republican Presidential Preference Primary, you must be an enrolled Republican. In order to vote in the Democratic Presidential Preference Primary, you must be an enrolled Democrat. There is a 90 day waiting period to change from one major political



party to another major political party. That cutoff date was January 26th. There is no waiting period to change from a minor party or from unaffiliated to a major party, or vice versa. Please call if you have any questions!
