News from the Town Clerk's Office

Ever wonder what goes on in the Town Clerk's Office?

Town Clerk 860-779-3411 Option 4 Fax: 860-774-5732 4 Wolf Den Rd PO BOX 356 The Clerk's office is one of the most-visited offices in the Town Hall. Daily, we see residents, attorneys, title searchers, realtors, builders, genealogists, and visitors looking for various information on our town. You probably know that the Clerk's office holds all the land records in town. But what does that mean? Every day, different types of documents are recorded on the land records for properties in town. This includes deeds, mortgages, liens, releases, maps, and many more. Think of all the properties in town and you can imagine the volume of records that come

across our desks! Land records are kept forever and in our vault we have records dating back to 1786. All our land records are open to the public so feel free to stop in and take a look!



Our second largest collection of records is our Vital Records collection. If someone was born, married or died in Brooklyn, a record of the event will be in our vault. If someone lived in Brooklyn at the time they were married or passed away, but the event occurred in another town in CT, we will have a resident copy of that vital record. If your

mother was living in Brooklyn at the time of your birth, we'll have that record as well. Certified copies of vital records can be obtained at any time from either the Town Clerk or the Assistant Town Clerk, both of whom are sworn-in Registrars of Vital Statistics appointed by the State.

The busiest month of the year in the Clerk's office is June—Dog License month! Did you know that by state statute, any dog over six months of age must be registered with the Town Clerk? Dog licenses renew every June and we'll process over 400 renewals throughout the month! The process is simple, bring your dog's up-to-date rabies certificate to the Clerk's office (along with a copy of the spay/neuter certificate if that applies), pay the fee, and we'll give you a dog tag. If you find a lost dog that has a Town of Brooklyn tag on its collar, please call us so we can help locate its owner!

Need to register to vote? Can't make it to the polls on election day and need an absentee ballot? The Clerk's office can help you! We have voter cards in our office that you can fill out anytime. We also process all absentee ballots for elections, primaries, and referendums. In last year's Presidential election, we processed almost 250 absentee ballots! If you have a question about any election-related item, chances are the Clerks can answer it for you.

Fishing season starts in April! Get your fishing & hunting licenses and permits in the Clerk's office. Remember, if you're over 65, the licenses are free!

There are many miscellaneous duties the Clerk's office can help you with. If you need a Notary, both the Town Clerk and the Assistant are Notaries Public. Our office records all Trade Name Certificates for those individuals doing business in town. We record copies of liquor permits and index Notary Public registrations. We hold the meeting agendas and minutes for all Boards and Commissions. The Clerk takes the minutes at all town meetings and we maintain the Town Meeting book in our vault. Veteran's Discharges (DD-214s) are indexed and kept in our vault for the Assessor's tax exemption requirements. We also perform bi-weekly, monthly, quarterly, and yearly administrative and clerical duties.

We hope this helps you, as a resident, understand what goes on in the Clerk's office on any given day.

- **ELDERLY and/or DISABLED HOMEOWNERS:** We are accepting applications until **Monday May 15th**, **2017.** To be eligible for this tax credit:
- You or your spouse must be at least 65 years of age as of December 31, 2016 or over 18 and permanently disabled per Social Security.
- You must be a permanent resident of Connecticut. You must own the property or hold tenancy for life or for a term of years, which makes the applicant liable for payment of taxes (CGS Sec. 12-48) as of October 1, 2016. The property must be the applicant's primary residence (domicile).
- Your 2016 income cannot exceed \$42,900 if you are married or \$35,200 if unmarried.

 You must provide the Assessor with a copy of your SSA1099 for 2016.

 Please call the Assessor's Office at 860-779-3411 option 6 to make an appointment to apply.



- **2016 ANNUAL INCOME and EXPENSE REPORTS MUST BE RETURNED TO THE ASSESSOR'S OFFICE BY JUNE 1, 2017:** All individuals and businesses who have received the form should complete and return the form to the Assessor's Office. All properties which are rented or leased, including commercial, retail, industrial and residential properties except "such property used for residential purposes, containing not more than six dwelling units and in which the owner resides" **must** complete the form. If a property is partially rented and partially owner-occupied the report **must** be filed.
- RENTER REBATE APPLICATIONS: Renter Rebate applications will begin Monday April 3rd, 2017. We will accept applications until Thursday September 28th, 2017. You or your spouse must be 65 years of age or older or over 18 and totally disabled through Social Security. Applicants must submit their SSA 1099 from Social Security for 2016 and proof of any other income, Federal Income Tax form if you were required to file, rent receipt for the entire year and information from Eversource (CL&P). All information must be

ADDITIONAL VETERAN'S APPLICATIONS: We are accepting applications until Thursday September 28, 2017.

for the 2016 year. Income cannot exceed \$42,900 for married or \$35,200 for single.

Armed Service Members: Connecticut Resident in Military Service or Exemption for Federal Soldiers & Sailors Civil Relief Act forms are available on our website and must be filed with the Assessor by December 31, 2017.

It's April and you know what that means! April showers and May flowers are here! Along with taxes!

- You can mail in a check to PO Box 253, Brooklyn, CT 06234.
- You can pay online with a credit card (2.50% fees for a credit/debit card, \$3.95 fee for a Visa Debit Card ONLY, and \$2.00 for an electronic check).
- You can also come into the office and pay in person with check, cash, or card (fees still apply if you pay in the office).

The due dates for this year's taxes are:

April 1st - May 2nd



Do you need to know what you paid in taxes last year for income taxes? You can visit the office for a printout or you can now print out your tax information online!

Tax Bills are now Online!



- Go to www.brooklynct.org
- Staying on the home page, scroll down until you see three yellow buttons.
- Click on "Online Payments." It will bring you to a link, click on the link.
- You will be brought to the search page. Type in your last name space first initial (ex. John Doe would type in Doe J).
- You will be able to see your tax bills, date(s) of payment, and how much you paid to the Town of Brooklyn during a calendar year. You can also print out your tax bills for your records.

From the Registrars of Voters

November 8, 2016 (Tuesday) – Presidential Election Day.

• The Polls opened at 6:00am and closed at 8:00pm at the Brooklyn Middle School for the 5,523 resident voters desiring to vote in the Presidential Election. We encountered a very enthusiastic group of voters all day and 3,782 residents actually came out to vote that day - a 72.4% turnout.

• Election Day Registration (EDR) was available from 8:00am to 8:00pm at the Registrar's Office at the

Brooklyn Town Hall. At the end of the day, we had 82 residents come in to register and complete their ballots for the election and were able to vote.

December 6, 2016 (Tuesday) – The Republican Registrar of Voters resigned.

• The Republican Registrar of Voters resigned her position and moved out of state. She had performed her duties for 4 years and had done a great job in serving the community.

February 2017 – A new Republican Registrar of Voters was appointed.

• During the Republican Town Committee Meeting held in January, the members chose to select Jo Ann Gerardi-Voccio to take the place of the Republican Registrar of Voters. She assumed her duties and responsibilities in February and is already actively working in that position.

February, March, and April 2017 – Registrars of Voters to undertake the annual Canvass of Voters.

• Beginning in February and lasting until April, the Registrars of Voters will be mailing letters to all residents



within the Town of Brooklyn who have not participated in any voting over the last 4 years. Each resident meeting those qualifications will receive a letter asking them to certify if they still live at a Brooklyn address and if they still wish to be listed as a registered voter. Their replies must be received by April or their registration will be de-activated and/or terminated as per state statutes. This process is one of the many ways that the Registrars of Voters manages to keep the active list of voters accurate and up-to-date.

General Information – The Registrars of Voters are looking for residents of Brooklyn who would be interested in becoming a certified Town Elections Moderator. We need at least 2 Democrats and 2 Republican

affiliated resident voters to fill these positions in the election process. Anyone interested should contact the Registrars of Voters Office by either leaving a voice-mail message, sending an email, or personally coming into the Registrars Office on any Tuesday between the hours of 1pm to 4pm. 

The leading cause of dryer fires is failure to clean them:

- clean the lint filter before and after each load.
- ★ Keep the area around the dryer clear of things that can burn, like boxes or cleaning supplies.

Test your smoke alarms once a month



Check your smoke alarms:

- Ensure smoke alarms are installed inside every bedroom, outside every sleeping area and on every level of the home.
- Test them at least twice a month.
- Replace batteries when you change your clocks.

Cooking fires:

The Keep anything that can catch fire off the stove top. Oven mitts, wooden utensils, food packaging, towels, etc.



Extension cords:

- The Check electrical cords to ensure they are not running across doorways or under carpets. Extension cords are intended for temporary use.
- The Have a qualified electrician add more receptacle outlets so you will not need extension cords.
